Motion made and seconded to approve the minutes of the November 29, 2022 meeting. **Peck and Jalbert in favor, Gessner abstained.**

Town Meeting Article – Increase COLA Base:

Marblehead retiree, Charles Maurais, sent a letter requesting the Board consider increasing the COLA base. The Board considered and discussed the issue noting the COLA base hadn't changed from \$12K since 1998. Motion made and seconded to submit an article for the Town Meeting warrant to increase the COLA base to \$14K. **All in favor.**

Chapter 269 of the Acts of 2022 – optional COLA increase to 5% for FY '23

On November 16, 2022, the Governor signed Chapter 269 of the Acts of 2022 into law. This Act provides local retirement systems with an option to increase the Cost of Living Adjustment (COLA) for fiscal year 2023 to up to 5% on the base amount specified pursuant to G.L. c. 32, § 103.

The local approval mechanism is different from traditional COLA increases. For a system to adopt a COLA increase pursuant to this act, the retirement board must vote for the increased amount and then get local approval from the Select Board. Motion made and seconded to increase the fiscal year 2023 COLA from 3% to 5% and seek local approval from the Select Board. **All in favor.**

2023 Operating Budget:

Moved and seconded to approve the 2023 operating budget totaling \$194,702.00. **All in favor.**
